## AusNet Services Restructure Proposal Implemented

AusNet Services is pleased to announce that the corporate restructure, under which a new company called AusNet Services Ltd became the single head company of AusNet Services in place of its current triple-stapled structure, was implemented today, 18 June 2015.

The number of fully paid ordinary shares in AusNet Services Ltd on issue is 3,466,913,009, which is equivalent to the number of stapled securities on issue on the last day of trading under the former structure. Normal trading in AusNet Services shares will commence on ASX and SGX-ST on Friday, 19 June 2015.
